RESOLUTION NO. 2007-007

A RESOLUTION OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA REQUESTING THAT THE COUNTY ESTABLISH AN EQUESTRIAN PARK FACILITY WITHIN THE TOWN OF LOXAHATCHEE GROVES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Loxahatchee Groves was incorporated as a rural town, and has a very long and proud history as an equestrian friendly community; and

WHEREAS, as part of the original Neighborhood Plan for the Town, the community expressed its desire to have Palm Beach County (the "County") construct a County park with an equestrian component within the boundaries of what is now the Town of Loxahatchee Groves; and

WHEREAS, when the County planned the development of the Loxahatchee Groves Neighborhood Park, the community desired the construction of an equestrian facility to meet the needs of the equestrian community in the Loxahatchee Groves area, including the consideration of a riding ring within the Loxahatchee Groves Neighborhood Park; and

WHEREAS, notwithstanding the communities desire to have an equestrian facility, the County did not construct an equestrian facility as part of the Loxahatchee Groves Neighborhood Park; and

WHEREAS, the Town Council of the Town of Loxahatchee Groves finds and declares that adoption of this Resolution is necessary, appropriate, and in the public interest of the citizens of the Town of Loxahatchee Groves.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA THAT:

Section 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2. The Town Council of the TOWN OF LOXAHATCHEE GROVES, Florida hereby recommends and supports the establishment of an equestrian facility within the Town of Loxahatchee Groves, and directs Town staff to work with Palm Beach County to find a location for such a facility.

Section 3. The Town Manager is directed to forward a copy of this Resolution to the Chair of the Palm Beach County Board of County Commissioners, the Mayors of Wellington and Royal Palm Beach, and the Executive Director of the Palm Beach County League of Cities

Section 4. If any clause, section, or other part or application of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part or application shall be considered as eliminated and so not affecting the validity of the remaining portions or applications remaining in full force and effect.

Section 5. All Resolutions or parts of Resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 6. This Resolution shall become effective immediately upon its passage and adoption.
