

**TOWN OF LOXAHATCHEE GROVES**

**RESOLUTION NO. 2007-013**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA, ADOPTING THE 2007-2008 SOLID WASTE COLLECTION AND RECYCLING SERVICE RATES FOR RESIDENTIAL SERVICE WITHIN THE TOWN OF LOXAHATCHEE GROVES; AUTHORIZING THE ISSUANCE OF BILLS TO COLLECT THE SOLID WASTE COLLECTION AND RECYCLING SERVICE FEES FROM PROPERTY OWNERS WITHIN THE TOWN OF LOXAHATCHEE GROVES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town Council of the Town of Loxahatchee Groves ("Town") has entered into an Agreement with the Solid Waste Authority of Palm Beach County for the continued provision of solid waste and recycling collection services within the boundaries of the Town for the 2007-2008 fiscal year; and

**WHEREAS**, pursuant to the Agreement, the Town is responsible for collecting the service fees from the property owners within the Town that receive residential solid waste collection and recycling services from the Solid Waste Authority's contractors; and

**WHEREAS**, the Town Council hereby adopts the fees contained in this Resolution for the provision of the service to the property owners within the Town, and authorizes Town Administrative staff to issue invoices and collect fees associated with the provision of solid waste collection and recycling services within the Town; and

**WHEREAS**, the Town Council finds that the provision of solid waste and recycling collection services as well as billing for these services is in the best interest of the health safety and welfare of the residents the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA THAT:**

**Section 1.** Each "WHEREAS" clause set forth above is true and correct and herein

incorporated by this reference.

**Section 2.** The rate for solid waste and recycling collection services to be provided within the Town of Loxahatchee Groves for residential parcels is as provided on Exhibit “A”, which is attached hereto and incorporated herein by reference.

**Section 3.** Pursuant to Ordinance 2007-08, adopted by Town Council on September 18, 2007, the Town Council hereby authorizes the collection of the rates as contained in Exhibit “A”, which is attached to this Ordinance. The Town Council further directs the Town Administrative Staff to take all action necessary to collect such fees from the property owners within the Town of Loxahatchee Groves that receive the service. In addition, Town Council authorizes Town Administrative Staff to take all action necessary to ensure that the fees are collected in a manner that insures that the Town will pay the Solid Waste Authority for the service provided pursuant to the Agreement between the Town and the Solid Waste Authority.

**Section 4.** If any clause, section, or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and shall in no way affect the validity of the remaining portions of this Resolution.

**Section 5.** All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.
