RESOLUTION NO. 2008-013

A RESOLUTION OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA REQUESTING THAT THE COUNTY OPEN THE ENTRANCE TO THE LOXAHATCHEE GROVES NEIGHBORHOOD PARK ON SOUTHERN BOULEVARD AND CLOSE THE ENTRANCE ON CITRUS DRIVE; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Loxahatchee Groves (“Town”) finds that the use of Citrus Drive as an entrance to the Loxahatchee Groves Neighborhood Park (“Park”) creates issues with respect to traffic on Citrus Drive; and

WHEREAS, the Town was incorporated as a rural town, and has a very long and proud history as an equestrian friendly community; and

WHEREAS, the amount of traffic on Citrus Drive entering and leaving the Park causes concern for those equestrians who use Citrus Drive on a daily basis; and

WHEREAS, Palm Beach County originally designed the Park with an entrance directly off of Southern Boulevard, and there is currently a curb cut on Southern Boulevard that can be used as an entrance to the Park; and

WHEREAS, in order to address the traffic concerns on Citrus Drive, the Town Council requests that Palm Beach County close the entrance to the Park currently on Citrus Drive, and establish the entrance to the Park on Southern Boulevard; and

WHEREAS, the Town Council of the Town of Loxahatchee Groves finds and declares that adoption of this Resolution is necessary, appropriate, and in the public interest of the citizens of the Town of Loxahatchee Groves.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA THAT:

Section 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2. The Town Council of the TOWN OF LOXAHATCHEE GROVES, Florida hereby recommends and requests that the Palm Beach County Board of County Commissioners take all steps necessary to establish and open an entrance to Loxahatchee Groves Neighborhood Park on Southern Boulevard, and close the entrance to the Park on Citrus Drive, except for emergency access, and finds the change of entrances to be in the best interest of the residents of the Town.

Section 3. The Town Manager is directed to forward a copy of this Resolution to the Chair of the Palm Beach County Board of County Commissioners, the County Administrator, and the County Engineer.

Section 4. If any clause, section, or other part or application of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part or application shall be considered as eliminated and so not affecting the validity of the remaining portions or applications remaining in full force and effect.

Section 5. All Resolutions or parts of Resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 6. This Resolution shall become effective immediately upon its passage and adoption.
