

RESOLUTION NO. 2016-13

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA, AWARDED BID NO. 2016-01 FOR “B” ROAD PAVEMENT SURFACING, TO HARDRIVES OF DELRAY, INC. d/b/a HARDRIVES, INC., IN THE AMOUNT OF \$1,033,008.80, AND AUTHORIZING THE EXECUTION OF A CONTRACT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town entered into an Agreement with property owners at the intersection of “B” Road and Southern Boulevard for the construction and funding of “B” Road south of Okeechobee Boulevard; and

WHEREAS, sealed Bid No. 2016-001, which provided for a Base Bid for an OGEM road and alternatives for an asphalt road, was then duly noticed, received and opened; and

WHEREAS, the Town received six (6) proposals, which were reviewed by the Town Engineer; and

WHEREAS, the Town Engineer has determined that the proposal submitted by Hardrives of Delray, Inc. d/b/a Hardrives, Inc., meets all the specifications, and recommends awarding the contract to Hardrives of Delray, Inc. d/b/a Hardrives, Inc. for Alternative No. 2 (asphalt road with 8” limerock base) in the amount of \$1,033,008.80; and

WHEREAS, the Town Council finds it in the best interests of the Town to award the bid and authorize the execution of a contract with Hardrives of Delray, Inc. d/b/a Hardrives, Inc., pursuant to the recommendation of the Town Engineer.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF LOXAHATCHEE GROVES, FLORIDA:

Section 1. Each “WHEREAS” clause set forth above is true and correct and herein incorporated by this reference.

Section 2. The Town Council hereby awards the contract for Bid No. 2016-01, Alternate No. 2, to Hardrives of Delray, Inc. d/b/a Hardrives, Inc., in the amount of \$1,033,008.80. Funds have

been budgeted through the Capital Improvement Fund.



The Mayor and appropriate Town Officials are hereby authorized to execute any and all documents necessary to complete the award of this proposal and contract, and the Town Clerk is instructed to deliver a copy of the signed contract to Hardrives of Delray, Inc. d/b/a Hardrives, Inc., along with a certified copy of this Resolution.

Section 4. This Resolution shall be effective immediately upon its adoption.
